3. OPERATIONAL REQUIREMENTS FOR LESSONS

■ **Permit Verification:** The Student must physically carry a valid learner's permit or driver's license during every driving session. Failure to produce a valid license immediately cancels the lesson, applying standard late fees.

■ **Appropriate Footwear:** The Student must wear safe, closed-toe footwear during all operations. Absolutely no flip-flops, sandals, slides, or high heels are permitted.

■ **Zero Tolerance Policy:** Spartan Driving School maintains a strict zero-tolerance policy for substance impairment. Instructors reserve full rights to immediately terminate a session without a refund if they suspect impairment from drugs, alcohol, or prescription medication.

■ **Vehicle Responsibility:** The Student is fully responsible for the training vehicle while operating it and shall exercise due care at all times.

■ **Instructor Authority:** The Student is required to follow all instructions given by the instructor while driving, without exception.

4. CANCELLATION AND RESCHEDULING POLICY

■ **Notice Requirement:** The Student must provide a minimum of 24 hours' notice to cancel or modify any scheduled behind-the-wheel instruction session.

■ **Late Cancellation Fees:** Cancellations made with less than 24 hours' notice, or instances where a student is a 'no-show' (exceeding a 15-minute wait window), will automatically incur a fee or count as a complete forfeiture of that scheduled lesson hour.

5. LIABILITY, INSURANCE, AND RISK ACKNOWLEDGEMENT

■ **Vehicle Safety Standards:** The School certifies that all training vehicles utilize functional dual-control setups and are fully bonded under mandatory state commercial auto liability insurance policies.

■ **Assumption of Risk:** Operating motor vehicles presents inherent risks of property damage, personal collision injury, or death. The Student explicitly agrees to follow all safety commands promptly and carefully.

■ **Traffic Violations:** If a Student willfully or intentionally violates traffic regulations against direct commands from the instructor, the Student and Guardian assume complete legal and financial responsibility for any resulting traffic citations.

6. REFUND AND EXPIRATION POLICY

■ **Refunds:** Tuition fees are refundable up to 75% of the value of any unused lesson hours. Lesson hours already completed are non-refundable.

■ **Expiration:** All purchased lessons will expire 12 months from the date of purchase, after which any unused hours are forfeited.
